

The WCD Committee on Nominations Report



The Nominating Committee was tasked with the responsibility of prayerfully discerning nominations for the Office of the District Superintendent, the District Executive Committee (DEXCOM), the Nominating Committee for District Conference 2021, and representatives for our National Nominating Committee for General Assembly 2020.

The committee began its work with prayer and continued in a spirit of prayer through the process. Through a series of discussions, the committee reflected on its responsibilities, gathered needed information from the constituency, and considered potential names that could serve effectively in each of the roles.

The process of selecting the nominee for District Superintendent was done according to the “Policy on Process for Electing District Superintendents,” which included several discussions, a public posting of the Call for Nominees, a review of evaluations done by DEXCOM and the President of the Christian & Missionary Alliance on the incumbent District Superintendent, and prayer.

The process of nominating DEXCOM members included an initial conversation with the District Superintendent and then further deliberations that took into consideration a balance of licensed and lay workers, as well as, geography, gender, ethnicity and skills.
